## New Powers mean Changes to Felling Licences in Wales

New powers under the Forestry Act will allow us to provide better



protection for wildlife and the environment during felling operations.

From the 1 April 2024, we will be able to condition, amend, suspend, or revoke a felling licence in Wales. We've now published new guidance on some of the new powers and how we will implement them.

Stephen Attwood, Regulatory Team Leader said:

"This guidance will help us to better safeguard habitats and species in Wales and provide protection from environmental damage during felling operations.

"Throughout the process of developing the guidance, it was important to us that we were engaging with the forestry industry and our stakeholder group, and we would like to thank them for their feedback throughout this process which has been invaluable.

"Many applicants who apply for a felling licence with us do not have a professional forestry background, and so we're hoping that this new information makes the conditions for felling clearer and easier to understand."

#### Sir David Henshaw said:

"We are now able to move our attention to initiatives elsewhere, and I was pleased to be able to share an update about our Teifi Demonstrator Catchment project."

#### New pilot to approve programmes of research

We're looking at whether it's possible to streamline the approval process for sub-studies within a programme of research.

Our pilot project will involve Research Ethics Committees reviewing an overall study application. If it gets ethics approval, any sub studies connected to the main study don't need to go through the same approvals process.

#### Call for comment on study template arrangement

We've worked in collaboration with the devolved administrations of Northern Ireland, Scotland and Wales, and the R&D Forum, on a new study agreement template.

The draft template is proposed for use between non-commercial sponsors and commercial organisations providing support for chief investigator initiated trials.

We are asking for feedback on the draft template and for suggestions to be shared before the deadline on 13<sup>th</sup> May 2024.

#### Making it easier for people to hear about research

We're working with partners on a project to recommend opportunities to streamline and standardise how patients are approached about taking part in research.

To do this we set up a small UK-wide project group, which included members of the public, to advise this work.
